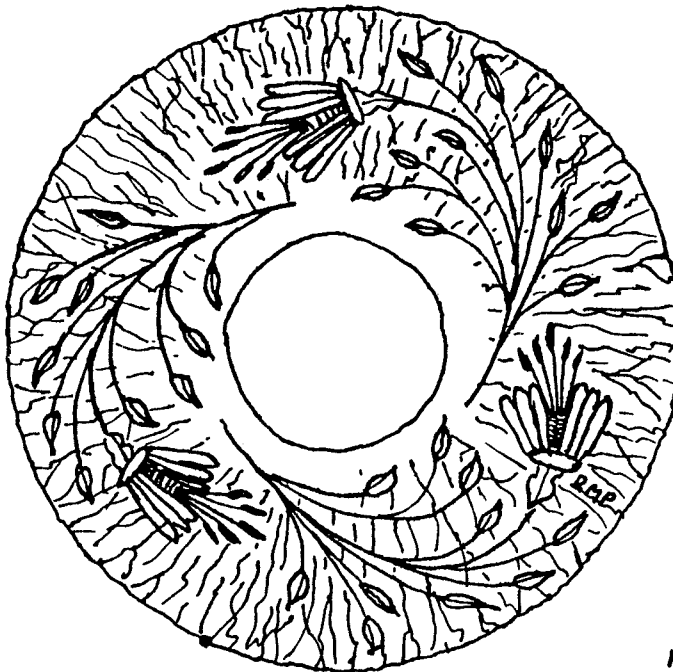

When I first read your letter of February 18 requesting permission to publish that catalog page showing the No. 316 candlestick, I assumed that you would publish it unless I told you not to. On re-reading the letter today I didn't get the same feeling, so thought I'd better let you know it's perfectly all right to go ahead and publish it. We actually show two No. 316 candlesticks. The difference in the two is in the stem. I believe that the one listed in the catalog sheet that I sent to you is probably the first one made. Perhaps the mould didn't work properly and the design was changed. In any event, the other one is the same as KU70 on Plate 8 in Umbraco's book.

Pretty soon I'll have to start work on my talk to the Convention. If you have any questions for me, I'll be glad to have them.

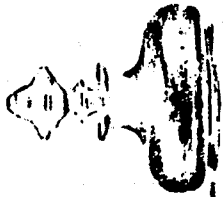

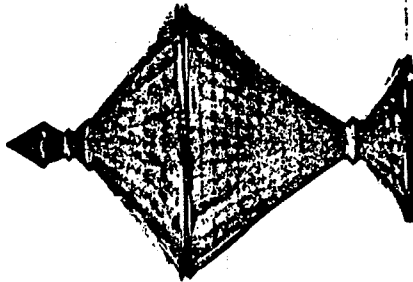


No. 316. Candle Stick

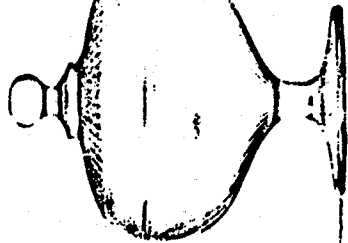

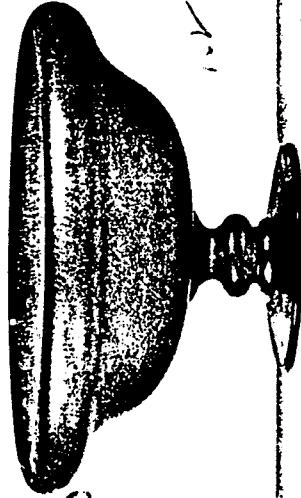

Dear Paul:

sell was lucky this weekend and found a cheese and cracker set in the United States Glass Company's 'Cumula' pattern. It is the cream and light green in a free form pattern that is enameled and fired onto the glass underside. We enclose a xerox copy of an ad from the Crockery and Glass Journal from 1922. It advertises the 'Cumula' line. We don't see this pattern or type of glass too often.

At a recent show a customer stated that only the rough surfaced stretch glass was really stretch glass. They also added that only the new stretch glass has the satiny finish. Of course, both statements are in the negative. Most of the old Imperial stretch glass pieces do have the heavy stretch finishes, but many of the old Fenton stretch glass pieces have a more satiny, softer stretch glass finish, as on the lemonade sets and many of the candy jars. Concerning the "new" having the softer finishes, the Fenton dolphin pieces do have softer finishes, but the Fenton epergnes certainly have the rough finishes. It is probably due to the chemicals and the amount of chemicals sprayed on the glass that makes the stretch finish. Perhaps Mr. Fenton will bring this up in his talk at the convention.

Dale Matheny would like to know if the stems on compotes give clues as to the manufacturer? The answer is yes, but they are hard to describe and also there are many exceptions as the stems are one of the most important parts of the designs of compotes and companies that made stretch glass for a number of years, such as Fenton, used many styles of compotes over the years of production.

Northwood liked to use the tree-bark pedestals and also pedestals which make the glass look like it has a bowl sitting on a pedestal - almost like two pieces of glass joined together to make one, such as KU55, KU121, KU146.

U. S. Glass liked to have a wafer-like piece of glass up near the top of the stem with a bulbous part right below the wafer which tapers to the foot, such as KU22, KU152. Sometimes they put a plain pedestal on the piece, but the pedestal seems to mold into the base of the bowl, such as KU171. They also made twisted stems, such as KU200.

Imperial many times used panel stems on their compotes. Fenton used a variety of stems for their compotes. Plain stems, such as KU2. Plain stems with a wafer of glass near the base of the bowl, such as KU151. Plain stems with a large bulbous part near the base of the stem, such as KU14. Paneled stems that continue the panel pattern from the bowl down to the stem to the base, such as KU193 and KU195.

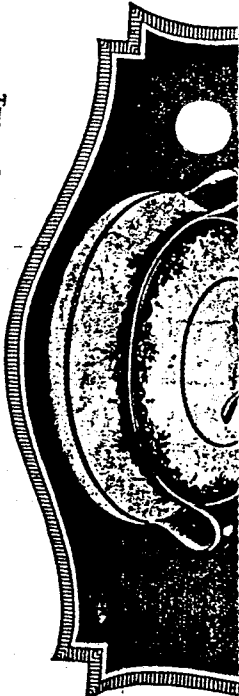
Dale also asked if sometimes unscrupulous dealers paint the edges of some pieces to cover chips and is there a way to tell if it has been done? Yes to both questions. How do you tell the difference? As an example, the Northwood Company sold stretch glass both with a gold edge and without. The best way that we know of is to feel the edge and if you find a rough spot, examine the spot carefully. On the enameled edges, if a piece of paint flakes off, you can still see the outline where the enamel was as it was baked onto the piece.

If anyone has any questions concerning stretch glass they should write to us. There will be a lot of stretch glass at our N.C.C.C. convention June 18, 19, 20 at the Stockton, California Holiday Inn. Everyone is welcome.

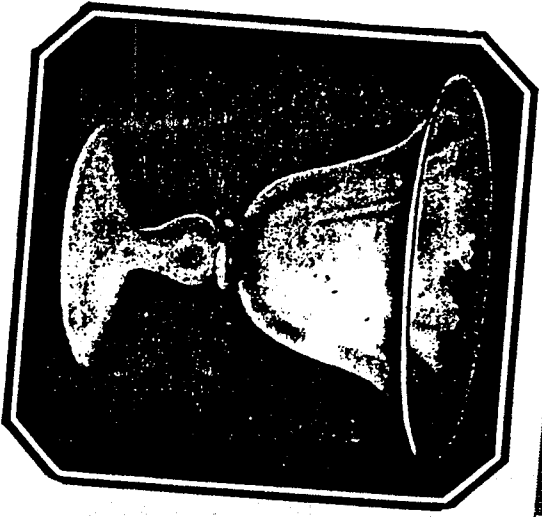

Dear Paul,

Have just finished reading the latest Stretch Glass Society newsletter. Found it very interesting and informative. If I keep telling you everything I know for the newsletter, I won't have anything new to tell the Stretch Glass people when they come here for the convention, but I think you're entitled to one more bit of information.

On page 7 you describe the illustrations on page 9 and you indicate some doubt about the origin of the candlesticks. I'm enclosing a photocopy of a catalog page that we have in our files showing the No. 316 candlestick which appears to be the same as the candlestick in your illustration on page 9. I have no date on this catalog sheet, but I'm assuming that it's sometime prior to 1921. Note that we were putting a black decoration on the No. 565 6" fan vase and a cutting on the No. 655 cigarette box shown in the same illustration. On second thought, that No. 565 might also be a cutting or a sandblasting.

In some of the later catalog sheets that we have we show the No. 316 candlestick with a stem that doesn't have the two rings on it. It's possible that we had trouble producing the No. 316 and made a new mould to get rid of the problems that might have been in the design of the stem. That's pure or impure conjecture. The vase on page 9 appears to be a Fenton vase but Northwood made some similar vases and so did others.

Amberina punch bowl and 15" amberina chop plate underneath	

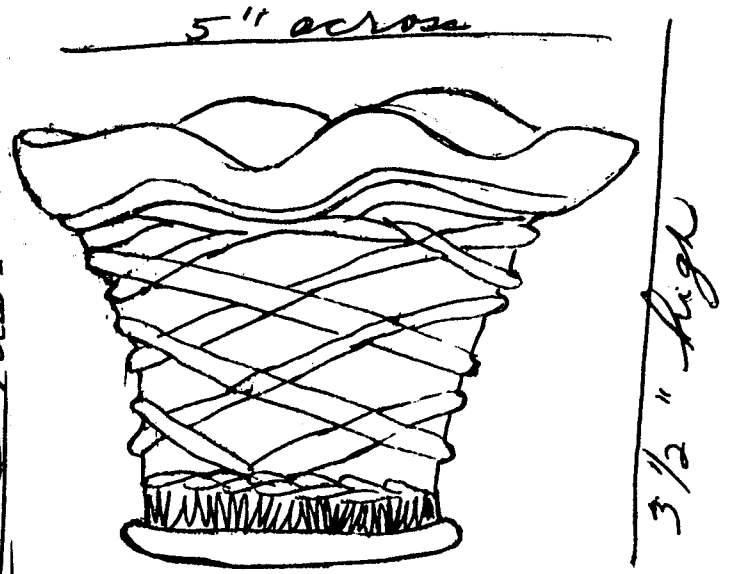
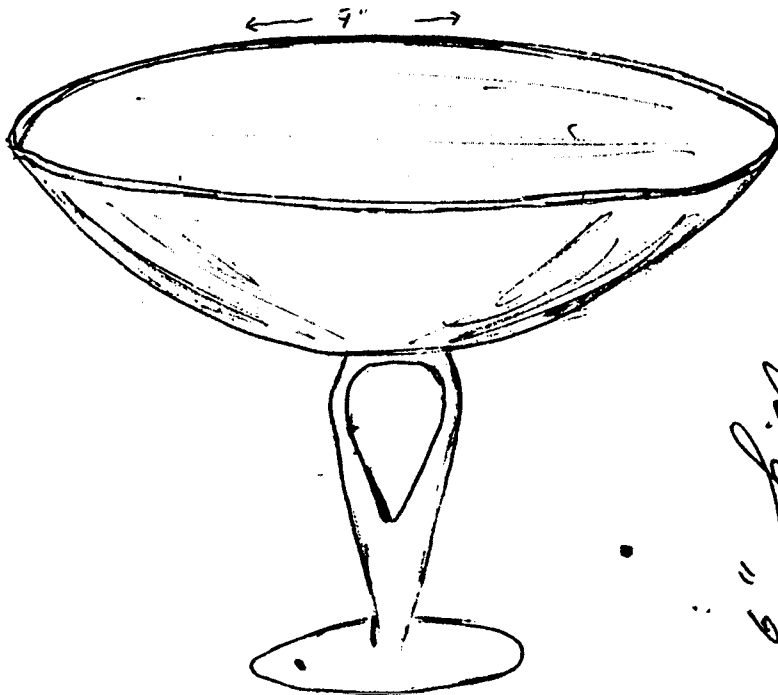
The last is quite beautiful but large and if anyone is interested we might sell. At an auction last week I was out-bid on a large compote with a blown stem containing a large bubble. It had

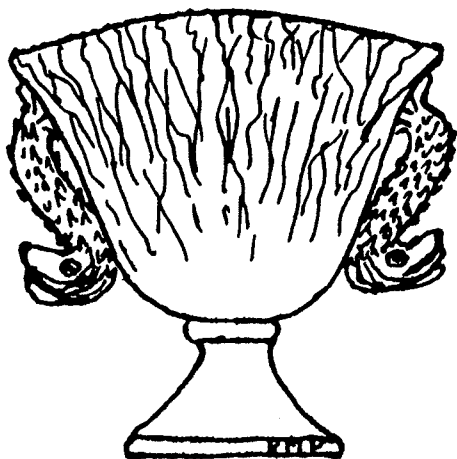
