Our business meeting was conducted following the banquet speaker, Helen Greguire. The following business was conducted.

A notice from the Museum of American Glass at Wheaton Village, N.J., was read. (see the attached)

A letter from Bud Walker of the Glass Research Society was read. Bud asks for our support in a letter writing project regarding the closing of the glass display at the Smithsonian.

John Madeley and Dave Shetlar audited the Treasurer's books and found them to be in good order. The Treasurer's report for the year was read and is included later in this newsletter.

John and Rose replace the outgoing Directors Mary Henry and Helen Stozus. There were no further nominations from the floor and Berry Wiggins made a motion that the slate of officers be accepted as presented. Wesley Bicksler seconded the motion and the membership approved.

At this point, Joanne Rodgers pointed out that this will be her sixth year as President and suggested that it's about time someone else began to think about replacing her. (Does everyone out there hear her?)

As has been the practice for the past several years, plans were begun for the convention to be held two years from now. Suggestions were requested for the 1993 convention. The suggestion was made that we return to our favorite spot, Marietta, OH. No other suggestions were made. Berry Wiggins and Joanne Rodgers will orchestrate the arrangements. As soon as a 1993 calendar can be found, we will let you know the exact dates.

An announcement was made that everyone who wished to come was invited to Rose's home to see her extensive collections of carnival glass, stretch glass, and other antiques. The Beedhams also extended an invitation to see their large collection of carnival glass and flow blue china.

It was noted that after being absent for several years, JoAnne and Anna Cummings of Houston, TX., and Bill and Jackie Davis of St. Marys, Ontario, Canada had once again joined us. Other members had travelled from Illinois, Indiana, Washington, D.C., Connecticut, New York, Virginia and Ohio.

All busines had been completed by 9:30 p.m. and Art Beedham moved that the 1991 convention be closed and Berry Wiggins seconded the motion. All members approved.

Our banquet speaker was Helen Greguire, author of Carnival Glass in Lights. No attempt will be made to repeat her talk since without her beautiful display of lamps and shades it would have little meaning.

Only a small portion of Helen's large collection was displayed. Glass shades were first produced for gas lights and then later, for electric lamps of all types. Some had been hand painted with beautiful scenery and others had only pressed patterns. There was a variety of styles and shapes. Some shades were made for simple candlestick lamps and others for multi-light chandeliers. Many of Helen's shades were of marigold carnival, and others were white, red, yellow, or blue. Thanks to Helen's husband, all of the lamps she brought could be illuminated so that we could appreciate their beauty.

Helen has also written a book on graniteware and is working on another. She is a very busy lady. We enjoyed having Helen and her husband with us for the evening.

The Executive Board and Board of Directors held an executive meeting prior to the regular business meeting. The following items were discussed and decisions made.

The President requested that an Historian be appointed to keep the photo album/scrapbook up-to-date. After our original scrapbook was lost in 1984, the President has been compiling a new photo album. A number of members have donated pictures from earlier years and Joanne has added pictures from all conventions since 1985. It is time this duty be given to another member. The suggestion was made that Rose Schleede be asked to fill the position. (Rose accepted the position. If anyone has pictures to add to our album, or any other material, please mail them to Rose).

The Treasurer presented a problem she has had (as did John Miller and Joanne Dolby) regarding the numbering system for memberships. The membership records passed on to John several years ago did not include a master file to original number assignments. We are now using numbers in the 500 area. With a membership of less than 70, this obviously does not provide an accurate indication of the size of our organization. The Board decided that beginning in April, 1992 no numbers will be used on the membership cards.

A request had been made that we consider changing the date of the convention to some other time other than the first of May. After a thorough discussion as to possible alternatives, it was decided not to change the date. Mothers' Day follows the weekend of our usual convention date, so would not be an alternative. If we move to later dates in May we begin to conflict with even more of the outdoor shows. Moving into early April brings the possibility of having to contend with a late snowstorm, a condition which did happen in the early years of the Society.

At the convention complimentary copies of the NEW YORK-PENNSYLVANIA COLLECTOR publication were brought in to the convention. This gave our Stretch Glass excellent coverage and to Rose Schleede who gave them a definition of stretch glass, how it is made and the books which are available at the present time, Berry Wiggins' and Umbracos'. It also mentioned another book is in the making by Dr. Maesell. The article was accompanied by many pictures of the glass and also a good item about our convention going on at that time.

Thank you, Rose, for getting us such good coverage.

THE MUSEUM OF AMERICAN GLASS

OPENS THE MAJOR EXHIBIT FOR 1991

MILLVILLE, N.J. - A brilliant arrangement of rare colored cut glass will blossom on Saturday, April 6 in the Museum of American Glass at Wheaton Village with the opening of the "Colorful Cutting" exhibition.

The exhibit features an array of American-made colored cut glass produced between 1876 and 1930 by such well-known companies as Tiffany, Dorflinger, Libbey and Hawkes and will be open to the public through Sunday, October 27.

Among the examples which will be included in the Museum exhibit is an elegant emerald green punch bowl set, cut in an intricate geometric pattern by C. Dorflinger and Sons. Another dramatic piece is an iridescent pitcher cut in a delicate floral and bordered design by the Tiffany Glass Company.

"In addition to the historic significance of these pieces, I would have to say that this is simply one of the most beautiful exhibits we've ever mounted," said Gay LeCleire Taylor, curator of the Museum of American Glass.

These unusual pieces in vivid shades of red, green, gold and blue were not believed to be part of a company's cut glass production line. They were usually created in response to requests from customers to mark special occasions.

Less than one percent of all the cut glass produced in America during the late 19th century and early 20th centuries was colored cut glass. The exhibit brings together 75 examples of this glassware, which will be housed in the Museum's Special Exhibition Gallery.

Pieces for the exhibit were loaned by private collectors and institutions, including members of the Empire Chapter of the American Cut Glass Association and the Jones Museum of Glass and Ceramics.

The Museum of American Glass and Wheaton Village will be open seven days a week from 10:00 a.m. to 5:00 p.m. beginning April 1. Narrated glassmaking demonstrations take place daily in the T.C. Wheaton Glass Factory at 11:00 a.m, 1:30 & 3:30 p.m. Current operating hours are Wednesday through Sunday, 10:00 a.m. to 5:00 p.m.

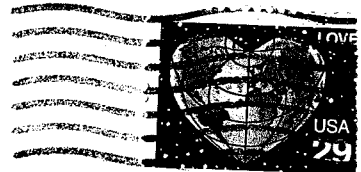
