U.P.S./R.P.S. DELIVERIES: Fenton prepays and adds cost to invoice. Claims to be reported to our Customer Service Department at once. Hold original carton for examination.
RETURNS: 10% restocking on returns. NO RETURNS will be accepted without written authorization.
BREAKAGE INSURANCE: Breakage insurance of 2% is automatically added on all Parcel shipments unless it is specifically refused. Refer to price list heading on front page for complete guidelines.
